

**DIRECTIONS FOR USE**

- Before use clean the sprayer to remove any oil or oil residues.
- Use a compression sprayer, fitted with a sieve no finer than 50 mesh.
- Half fill the sprayer with clean water and then, using the scoop provided, add Cytrol Forte WP, according to the table below. (One level scoop is equal to 10g product).
- Add the remainder of the water, close the sprayer securely, shake to disperse the contents and pressurise according to the sprayer manufacturer's instructions. Shake the sprayer again if spraying is interrupted for more than 15-30 minutes.
- One litre of ready-for-use(RFU) spray will treat 25 square metres.
- Make spray suspension as required. Do not store RFU spray overnight.
- Do not use water-based sprays around electrical appliances, light fittings or switches.
